DENSITY AERIAL




Property Overview

Kings Contrivance is a Harris Teeter anchored mixed-use center with retail and 2nd floor offices. Two opposite rows of retail overlook a landscaped courtyard that features a popular summer concert series. In addition to serving the residential neighborhoods nearby, there is a nearby business park which provides daytime visitors. The center, which opened in 1986, is Columbia's southernmost retail center and is located 1/2 mile south of Rt. 32 at Eden Brook Drive and Guilford Road.




